The Board of Liberty County Commissioners met in regular session on the above stated date at 10:00 AM in their room at the Courthouse. Those present were: Chairman Rlynn Rockman, Commissioner Larry Hendrickson, and Commissioner Russ Tempel.

LEPC

Eight members attended LEPC monthly meeting. EMS hosted a "block party" in the Gagnon addition for street/ bike safety for kids who are curious when alarms go off. EMS office reconstruction is essentially complete. Tara is working on an MDT grant for a rescue truck. EMS has a new TV in the training room for teaching purposes. Darrell will pursue upcoming grant applications for generators at the Senior Center and CJI School.

COUNCIL ON AGING

Commissioner Rockman attended the monthly meeting for Council on Aging. Treasurers report = \$20,053. Still waiting to hear from Frontier Landscaping on boulevard bid for CTEP grant. Meanwhile, Glenda called nurseries regarding tree prices/ recommendations. No other issues.

COUNTY SALARIES

Current county wages were submitted for approval. A motion was made by Commissioner Hendrickson and seconded by Commissioner Tempel. The motion passed to pay these salaries.

SENIOR CENTER

Glenda Hanson came in to discuss Senior Center issues. The old bus is "heating up" on hot days on trips to Great Falls, so they plan not to use it for long trips/hot days. Glenda took a trip to Great Falls with driver Ken Watson, to observe his driving abilities.

PERMISSION TO LEAVE THE STATE

Holly Frederickson asked to leave the state from Thursday (8-7-14) to Monday (8-11-14). A motion was made by Commissioner Hendrickson and seconded by Commissioner Tempel. The motion passed.

DEPARTMENT OF REVENUE

Conference call by the Commissioners with DOR (Gene Walborn and another rep) regarding current tax valuations. We learned that assessments for classes 4 and 8 "Industrials" (elevators, etc.) for last year were \$15.4million market value (\$463,000 taxable value) compared to this year \$24.6million market value (\$645,000 taxable value). The other centrally assessed enterprises (utilities, railroad, gas/oil, etc.) last year were \$35.3million market value (\$1.5million taxable value) vs. this year \$35.4million market value (\$1.6million taxable value). Therefore, these centrally assessed items are up \$300,000 in taxable values. Liberty County's \$400,000 total reductions in taxable values for 2014 are probably due to the \$100,000 personal property exemption. They will email us a better "breakdown" of the reports.

ROAD DEPARTMENT

Marc Holmes stopped in to discuss road issues. Grading is being done due to recent rainfall. Our leased Case tractor was picked up by Torgerson's, who sold it. A replacement is coming.

EXTENSION SERVICES

The fiscal year 2015 Extension Services agreement between MSU Extension and Liberty County was offered for approval. The contract addresses the county's share of the agent's salary (\$24,756.00), administrative support salary (\$31,511.00), staff benefits and termination pay (\$23,400.00), and operations expenses (\$14,975.00); the total contract = \$94,645.00. A motion was made by Commissioner Tempel and seconded by Commissioner Rockman. The motion passed to sign the agreement.

WEED DEPARTMENT

Jim Ghekiere stopped in to discuss weed issues. We asked him to spray the county lot near the Senior Center and the boulevards south and west of the Senior Center parking lot. Two crew members (Mike Hamel, Charlie Diemert) will be going back to college soon. Crew member Wayne Wardell has been essentially part time due to blood pressure/ pulse/ medical issues. Last 2 crew members (Stan Huhtala and Eric Kelly) will work into the early fall on Russian Olives and late spraying.

Jim shared a recent incident on the spray boat. Wayne was controlling the injection pump, which has a sensitive adjustment screw that controls pressure on the diaphragm. The typical pressure is 35lbs., but Wayne adjusted the pressure to over 200lbs. and exploded the diaphragm. No injuries, repair costs = \$399. We told Jim to fill out an incident report with remedies for documentation.

The Board of Liberty County Commissioners met in regular session on the above stated date at 10:00 AM in their room at the Courthouse. Those present were: Chairman Rlynn Rockman and Commissioner Russ Tempel. Commissioner Larry Hendrickson is available by telephone.

COUNTY CLAIMS

The current county claims were offered for payment. A motion was made by Commissioner Tempel and seconded by Commissioner Rockman. The motion passed to pay these claims.

BOR

Mike LaFrenz from the BOR stopped in to say "thanks" for removing the two toilets and cleaning up the two sites near the Marina. These two toilets went to the 4-H campground. FYI: We leased a crane from Dick Irvin's to lift and re-set the two toilets (\$1480); we used county equipment (backhoe/trucks/etc.=\$0); estimated cost of supplies (hooks/chains/safety fences/fuel= \$2000); and estimated cost of road crew staff (wages/benefits = \$1,500). Therefore, we have around \$5000 invested in these two toilets. Current costs for similar (new/updated) toilets are around \$40,000 each! Our local 4-H Council Board has agreed to reimburse us for part of our costs.

S AFETY COORDINATION

Julie Gagnon will be attending a MACO recommended safety conference in Havre next week. Meanwhile, she completed an updated "written hazard communication" program for our safety manual.

LIBRARY

Librarian, Teresa Fenger, stopped in to discuss a storage shed for the back lot of the library. There are safety concerns in retrieving stored supplies for the library attic (pull-down ladder with steep stairs, confined spaces, narrow access, etc.). She's looking at a 12'X 20' structure with a metal roof/siding and a wide/secure walk-thru-door. A quote from Western Lumber = around \$4000 without a cement floor. We discussed a wooden floor on skids. Vern Holmes may have time to build it later this year. Discussion to continue.

LIBERTY ELEMENTARY SCHOOL DISTRICT

Rlynn Rockman, Russ Tempel, and Rachel Ghekiere had a conference call with David Hofer and Todd Hanson regarding Liberty Elementary. Todd runs an educational consulting firm in Havre and has worked with Eagle Creek Colony for the past seven years. He presently is contracted with OPI on a Hays-Lodgepole school issue. He will be assisting with Liberty Elementary's timely paperwork through the transition period in appointing a new Liberty County Superintendent of Schools. Dave Hofer wants everything to run smoothly, so not to jeopardize their status with OPI. Both men "thanked" Rachel for her dedicated service in the capacity as County Superintendent.

LIBERTY COUNTY SUPERINTENDENT OF SCHOOLS

Rachel's last official day on the job is August 13th. The current school budget/levies are being finalized next week and must be available for Commissioner approval by August 31st. Rachel has agreed to process this budget paperwork for us on a contractual basis. We have yet to hear from the Republican Central Committee regarding names for her replacement.

The Board of Liberty County Commissioners met in regular session on the above stated date at 10:00 AM in their room at the Courthouse. Those present were: Chairman Rlynn Rockman, Commissioner Larry Hendrickson, and Commissioner Russ Tempel.

WEED DEPARTMENT EMPLOYEE

We requested a meeting with Wayne Wardell, Weed Department employee, to discuss several "incidents" involving his work performance this summer; namely,

- 1. Poor decisions after getting the land-tamer stuck at the lake'
- 2. Lack of attentiveness in the control/explosion of the pressure pump on the weed boat,
- 3. Recent judgment on cruising the Whitlash Road on the wrong side of the roadway during a busy traffic season (AKA: harvest time), and
- 4. Recent use and/or abuse of sick leave benefits.

After a long visit with Wayne, he admitted to continuing health issues and general unhappiness/dissatisfaction with his job at the weed department. We discussed liability issues and the fact that we have been very accommodating/workable to keep him employed this past 1 ½ years. Consequently, we asked Wayne to offer his resignation with two weeks' severance pay, effective immediately. If not, we will seek immediate action via MACO legal division to dismiss him. He will let us know tomorrow.

Additional note: Wayne vented about inconsistent changes in the weed department by management, poor communication between management/employees, abuse of equipment by some employees, need for better training of younger employees, spraying in adverse conditions, etc. He also expressed concern about us calling his physician (Heidi Fritz, FNP) in June, which he said "violated the HIPAA laws". We called only to ask Heidi's interpretation on "No limitations" regarding Wayne's job description/expectations.

SENIOR CENTER

Glenda Hanson stopped in to discuss center issues. They have a "hot" smell this morning in the pantry rooms; possibly a fan. Glenda did submit the "landscaping bid" from Great Falls nursery to Pam at Bear Paw Development regarding the CTEP grant.

ROAD DEPARTMENT

Marc Holmes was in to discuss road issues. They worked Blackjack Road cattle guards yesterday to accommodate locals who are hauling hay. Two cattle guards at Engstrom's will be repaired tomorrow. Wanken's called about a culvert near the cemetery; it will be repaired this week. Marc and Charlie managed to retrieve around 400 yards of gravel from the pit floor at the Mark Wickum pit. Bus stop signs (2) have been requested for the Green farm on the Laird Road. Jerry is getting the new fire truck set up (new bed), then he will get the new service pickup done. They repaired the "settled" area near the border crossing last week. Marc will be on vacation on September 2/3/4.

TOWN OF CHESTER

Mayor Noel Walston stopped in to discuss the fire alarm siren. It was inspected by Jim Vinson (North Western Energy) and repaired by Dale Pimely (electrician); so it now works. However, a new pole will not be installed without further request because it requires an expensive 3-phase meter (there is presently no meter in place). In addition, the city would like the siren/pole relocated. Suggestion: is there some money available through 9-1-1 funds to purchase a modern digital siren? Jim Ghekiere was contacted. He will work with Tara Hendrickson to find answers.

HUGH BROWN, COUNTY ATTORNEY

We asked Hugh Brown to pursue renewing the 501C3 status for the Liberty County Museum.

SCHOOL BUDGETS & LEVIES

Budget reports for the three Liberty County School Districts were presented by County Superintendent (Rachel Ghekiere) for approval. Rachel had calculated the County Transportation and Retirement Fund at 60%, 65%, 70% based on our oil and gas production taxes and interest income. Because the gas and oil distributions were down significantly from July 2013 to July 2014, Commissioner Tempel made a motion to approve the 60% calculations (motion seconded by Commissioner Hendrickson and passed). Additional motion was made by Commissioner Hendrickson and seconded by Commissioner Tempel. The motion passed to approve the three budget reports as submitted.

CORRESPONDENCE WITH MDOT

We received a note from MDT regarding project priorities for secondary roads. LIBERTY COUNTY MUSEUM

Commissioner Tempel and Commissioner Rockman attended the year end meeting of the Museum Board. Their beginning balance on 7-1-2013 = \$16,675.00 and ending balance on 6-30-14 = \$16,697.00. During the year, \$8,512 was disbursed to the Liberty Village. The museum presently has around \$21,000 in their memorial fund. Several proposed gifts (non-monetary) were discussed (i.e. a saddle from the Prescott family dating back to the 1920's). Several repairs requests were made:

- 1. Roof on Gau building
- 2. Sheetrock on ceiling to old school building, and
- 3. Move the gas pumps in the display lot.

COUNTY SUPERINTENDENT OF SCHOOLS

A motion was made by Commissioner Hendrickson and seconded by Commissioner Tempel. The motion passed to appoint Kathy Armstrong to fulfill the remaining term of Rachel Ghekiere (ending 12-31-2014) as County Superintendent of Schools. Holly Fredrickson swore her into the position. She will begin her duties on September 2nd.

GIS / GPS GRANT

Gail Shatkus came in to discuss some final items to be completed to bring the project up-to-date. Commissioner Hendrickson is to meet with CJI administration tomorrow.
